

### Notes to 2008 990-EZ

#### Part I, Line 10 Grants

For 2008, all grants (\$155,500) for water project implementation were paid to A Glimmer of Hope Foundation, Austin, TX (also a 501 c (3)). Glimmer of Hope is our implementation partner in Ethiopia and manages the implementation of our water projects with its staff in Addis Abba. Glimmer of Hope passes 100% of the grant through to the project cost and does not require any compensation for its management services. The following project grant payments totaling \$155,500 were made to Glimmer of Hope for the 2008 projects:

- \$35,000, Northern Ethiopia, Tigray zone, 12 projects, hand dug wells
- \$68,000 Western Ethiopia, Kellem zone, 21 projects, hand dug wells and spring systems
- \$17,500 Southern Ethiopia, Kafa zone, 5 projects, hand dug wells
- \$35,000 Western /Central Ethiopia, Kellem and Oromia zones, 11 projects wells and spring systems and bore hole well

These projects provided clean disease-free water for approximately 25,000 rural Ethiopians who previously had no access to safe water.

At year end, Water to Thrive had \$12,585 of merchandise inventory and \$1,611 of other misc. net assets.
