During calendar year 2011, Water to Thrive completed or partially funded more than 75 rural community projects for communities in Africa, primarily Ethiopia and Sierra Leone. These projects include not only the physical construction of the water project, but also training of a water council for each project and providing water, sanitation and hygiene training for all family units benefiting from the project. The water council is comprised of at least six elected members from the community, half women and half men. The water council is responsible for managing the project, including sustainable maintenance by establishing a maintenance fund funded each month by the family units using the project.
