In 2019 Water to Thrive provided grant for the construction of 130 fresh water wells in Sub-Saharan Africa. Approximately 75,800 vilagers were beneficiaries of these projects.  
The immediate benefits of all well projects are a clean, and therefore, safe source of water for drinking, cooking and household needs. Immediate as well as long term benefits also include sanitation and hygiene training for all beneficiaries.  
Long term benefits include a sustainable clean and safe water source resulting in healthier communities, improved educational opportunities and social and economic security.

Because of variables between menus, the number of quests and required chef support staff, it is difficult at best for Water to Thrive to identify, and therefore notify, the donor of the value of goods and services provided. Water to Thrive depends on the participating chefs to calculate the value of the dinner and provide that information to the donor once the details of the dinner have been established.
